Celebrating Easter : Part 8

Easter is the feast which sets Christianity aside from all other traditions - religious and even non-religious! Easter started Christianity!

The first disciples of Jesus after his death were lost and in hiding for fear that what happened to him might happen to them. The authorities were so keen to be rid of Jesus that they would be likely to want to stamp out anything which was associated with him.

Like the two disciples on the road to Emmaus in Luke Chapter 24, they were disillusioned and ready to give up. Those two disciples walking away from it all were symbolic of what was true of the other disciples. Their expectations were - as the gospels so often attest - that Jesus would show himself the great and conquering Messiah despite all he had said in his life time.

The women report the empty tomb but it seems that there was an attitude something like "Well that's just the women" !

When it borne in on them that he was alive beyond death, even that took time to sink in! But that was the point of all that would become the Christian Faith. He was alive beyond death even though he was so so different that as the accounts of his presence after death show us they had trouble recognizing that it was indeed him. Not just his influence or inspiration, but HIM !

How does the conviction get planted in us that he is still alive?

Well looking at Luke 24 and the two disciples walking away from it all to Emmaus, we can see the answer to that question.

On that journey in which they discover Christ, two magnificent things happen. First the stranger (Jesus) explains the Scripture to them and how they lead up to what has happened to Jesus in Jerusalem. They report that their "hearts burned within them" as they listened to him. Secondly, when they invited him to eat with them, and he did what he had already done at the Last Supper, they recognized him with them.

Two other things are important : they recognized Jesus in an act of prayers and after they recognized him they went back to the other, to the community or the brotherhood as they would have called it.

So from these things : the word, the Breaking of the Bread, prayer and the community of Faith. All played their part in their coming to the conviction that Christ was alive.

St Luke in his second volume, the Acts of the Apostles, says that the first disciples remained faithful to "the teachings of the apostles, to the brotherhood, to the breaking of the bread and to the prayers" (Acts 2.42).

These same four things are crucial in our coming to the recognition of Christ's being alive beyond death and for us they are the gospels (reading of the apostles), the brotherhood (the community of faith), the breaking of the bread (the Eucharist) and prayer (the prayers). What was necessary for them is necessary for us !

"ALLELUIA"

IT is an unusual word that is not native to the English or even the Latin liturgical vocabulary : the word "ALLELUIA". As a matter of fact, it sounds less like a meaningful word than the babbling of a child, and when it is sung with many notes for the final vowel, this impression becomes even stronger.

"Alleluia" does, of course, have a meaning. It is a Hebrew word, and down the centuries the church has brought it with her, untranslated (like "Amen"), as a product of the Jewish soil from which she herself sprang and as a reminder of her earliest days. The word is a cry of jubilation meaning "Praise the Lord", and occurs frequently in the psalms.....

But the translation does not explain why the church chose and retained this word from the Hebrew language of prayer in order to express her Easter jubilation, even though in later centuries her own children did not understand the meaning. I think the church meant to say: "In the presence of the mystery that we celebrate on Easter, the mystery of our redemption, our usual intelligible vocabulary is inadequate; when faced with the superabundant mercy of God we can only stammer in amazement like children."

That is how it is with us Christians: As we gaze at the Sun that has risen high over the darkness and cold of our Good Friday, all well-chosen words are useless. We can only stammer out our Alleluia of wonder and jubilation.
